RELEASE, WAIVER OF CLAIM, AND ASSUMPTION OF RISK WARNING

Ammena Dance Company will be referred to herein as the "Company".

The undersigned acknowledges that dance has inherent risks. These risks are increased by COVID-19.

The Company will endeavor to act reasonably, but the Company is not able to assure nor guarantee that the services it provides, or anyone else provides, will provide a trouble-free or risk-free experience for all participants.

The undersigned releases the Company, its employees, volunteers, agents, coaches and all representatives whatsoever, and all representatives whatsoever (collectively, the "Releasees") from all liability and hereby waives, as against the Releasees, all recourses, causes of action, or claims of any kind for loss, damages, or injury, including any consequential loss or damage, and voluntarily accepts the legal risk, thereby expressly giving up any right of action from the physical risk arising from any actions of the participant at the Company, whether related to dance and/or to COVID-19.

The undersigned further acknowledges and agrees that:

1. Dance can be dangerous and exposes all participants to many risks and hazards, some of which are inherent in the very nature of the activities. These risks are now increased by COVID-19.
2. As a result of the aforementioned risks and hazards, participants may suffer personal injury, loss illness or even death as a result of their presence and actions in dance.
3. Some of the risks and hazards are foreseeable, but many others are not.
4. The undersigned, nevertheless, freely and voluntarily assumes all possible risks and hazards, and acknowledges that the use of the Company's facilities, while participating in any activities, shall be at the participant's own risk, or at the risk of those for whom the undersigned is a guardian and/or caregiver.
5. The undersigned understands that the Releasees do not assume any responsibility or liability whatsoever for the participant's actions while engaged in any of the activities or using any of the Company's facilities in any way.
6. The undersigned has carefully read this Release, Waiver of Claim, and Assumption of Risk Warning, and declares that it is understood it and that it is freely and voluntarily executed.
7. By signing this Release, Waiver of Claim, and Assumption of Risk Warning, the undersigned will be FOREVER PRECLUDED FROM SUING OR OTHERWISE CLAIMING AGAINST THE RELEASEES for any loss, damage, injury or death the participant may sustain.
8. The undersigned understands that Company will not permit the participant to use their facilities unless this Release, Waiver of Claim and Assumption of Risk Warning is signed.
9. This Release, Waiver of Claim, and Assumption of Risk Warning is binding upon the participant, their heirs, executors, administrators, personal representatives, and assigns.
